2. Membership, Term, and Payment.

- a. Membership. Your Membership entitles you to use the Facility until your Membership Expiration Date, below, and is created when you execute this Agreement.
- b. Fee. Your fee is based on the length of your membership (“Membership Fee”). Your Membership Fee will be paid in one (1) lump sum for a twelve-month period, or pro rata in joining during a calendar year. Membership runs from 1st January to 31st December.
- c. Closings. From time to time, the Facility may partially or fully close and be unavailable for use for reasons including, but not limited to, renovation, repair, special events, or holidays.
- d. Access. Members access to the facility includes the members lounge, training room and boardroom during normal office hours, or when the Innovation Centre is open. The training room and boardroom must be booked prior to use (booking fee may be applicable)

3. RIGHTS TO CANCELLATION

MEMBER'S RIGHT TO CANCELLATION.

YOU MAY CANCEL THIS AGREEMENT WITHOUT ANY PENALTY OR FURTHER OBLIGATION BY CAUSING A WRITTEN NOTICE OF YOUR CANCELLATION TO BE DELIVERED IN PERSON OR BY POST TO THE ADDRESS SPECIFIED IN THIS AGREEMENT.

Your notice of cancellation shall be accompanied by the Required Forms, including this Agreement, your membership card, and any other documents or evidence of membership previously delivered to you. In the event of your cancellation of this Agreement in the manner specified by this Section 2, the Network shall not refund any money paid by you to the network. Your membership can be transferred within the company in the event of the termination of your employment contract.

4. MISCELLANEOUS

1. Confidentiality. Information you provide to the Network pursuant to this Agreement, including but not limited to that information provided in the Required Forms (the “Confidential Information”), will be treated by the Network and its personnel as confidential, and will not be released or revealed to any person outside of the Network without your express written consent or as required by law. The Network shall employ reasonable and appropriate safeguards to protect your Confidential Information.



2. Assignment. You may not assign, resell, or transfer to any other person or entity the rights allowed or obligations required by this Agreement.

3. Waiver. It is understood and agreed that no failure or delay of either party to this Agreement, in exercising any right, power, or privilege provided under this Agreement, shall operate as a waiver, nor shall any single or partial exercise preclude any other or further exercise or the exercise of any right, power, or privilege provided under this Agreement.

4. Governing Law. This Agreement shall be governed by the laws of the United Kingdom.
